Deadline	Task	Details	If Not Completed
August 4 th 5:00PM	Send Sale Photo And Biography telling us about you!	All exhibitors participating in the 2021 Premium Sale are required to submit a sale picture. Please send the sale photo and up to 150 words of a biography telling us a bit about you to jrlivestocksale.bcf@gmail.com . The sale photo <u>MUST</u> have a file name that matches the exhibitor's <u>name</u> . All sale nominations are due by Wed, Aug 4 at 5:00pm, no late entries will be accepted.	No sale photo of you or your animal included – BORING! No description of you to tell potential supporters what an amazing person you are!
August 4 th	Complete Sale Intent form	Sale Intent https://forms.gle/nCtteK8GgEMNqH9Q6 required for all exhibitors participating in the 2021 Premium Sale. Each market exhibitor will get to nominate 1 animal for the sale.	Not eligible to participate in livestock sale event.
August 4 th	Complete Resale Buyer portion of Sale intent form! Need a place for your market ready animal to go?	Need a place for your market ready animal to go? A resale buyer will purchase any market project animal BUT the exhibitor must have indicated this option at nomination time on the Private Treaty portion within the google nomination/sale intent form above, and must deliver the animal(s) to a designated time and place for pick up. Sale price will be the current market price. Check with your species superintendent for delivery date/time.	Take your animals home or to your own processing date/location.
Your Species WEIGH IN DAY of Fair	Complete the Wholesome Meat Act Form	All Wholesome Meat Assurance Act rules and regulations must be adhered to. See Jr. Exhibitor Livestock and Animal General Rules under USDA Wholesome Meat Act. Complete the Wholesome Meat Act form, this form <u>MUST</u> be completed by the species fair weigh in https://forms.gle/A65gXoSh7PJMCHUA	Not eligible to participate in livestock sale event.
September 1 st	Receive list of buyers/sponsors	Ten days post sale exhibitors will receive a notice from jrlivestocksale.bcf@gmail.com and are to complete thank you letters to each of their buyers/supporters on the list. Take a photo of them. Mail thank you notes to sponsors. Then send photo or copy/scan to the livestock sale committee email jrlivestocksale.bcf@gmail.com by 2 nd Friday in September	See next section
2 nd Friday in September	Copy of all Thank you notes due to email/sale committee	A CLEAR organized photo of letter, addressed envelope with stamp that can be CLEARLY seen to each sponsor must be sent to the sale committee for verification. Send to: jrlivestocksale.bcf@gmail.com	Failure to submit the photos of the letters by the second Friday in September will result in a \$100.00 fee being deducted from the exhibitor's check.
