2. Learn and live by the principles of the 4-H Pledge, 4-H Motto and 4-H Slogan.

3. Adhere to program rules, curfews, dress code, policies and guidelines.
4. Abstain from illegal and immoral behaviors. Illegal drugs, alcohol or tobacco products are not allowed at any 4-H sponsored program, event or activity.
5. Fully participate in scheduled activities.
6. Respect other's property and privacy rights.
7. Respect the rights and authority of leaders, coaches, instructors, parents and Extension Agents.
8. Refrain from physical and verbal abuse.
9. Apply rules of safety to individuals, groups and property.
10. Accept personal responsibility for behavior.

Conduct not keeping with high 4-H standards will not be tolerated. Violation of the code will result in consequences to the participant. Consequences may include removal, at the individual's expense and without refund, from participation in an event, restitution or repayment of damages, sanctions on participation in future 4-H events, forfeiture of financial support for an event, removal from offices held and suspended for "minimum" of one year of participation in 4-H Shooting Sports program.

## **Section 2: General Operating Procedures**

1. Have a current Colorado 4-H Event Plan complete and on file.
2. Refer to the current Colorado 4-H Youth Development Policies, Colorado 4-H Shooting Sports Leader Training Manual, and Colorado 4-H Shooting Sports State Championships Contest Rule Book.
3. Whenever firearms, archery or related equipment is being used, the Certified 4-H Volunteer must be immediately accessible and able to oversee the entire range. The Certified 4-H Volunteer must be alert to conditions that may be dangerous to shooters and take preventive action if necessary. Certified 4-H Volunteer supervision is required during all phases of the event or activity as well as while shooting.

4. All members participating in 4-H Shooting Sports projects must be able to demonstrate their understanding of safety procedures and to handle equipment safely. A participant enrolling in .22 Pistol or Western Heritage projects must have completed one year of 4-H Shooting Sports that includes live fire range experience with a firearm or air gun and complete a safety proficiency with the instructor prior to approval of enrollment in the project.
5. Instructors/coaches must be approved & enrolled 4-H volunteers, at least 21 years of age and hold a current Colorado State 4-H Shooting Sports Leader Certification in the discipline for which they plan to instruct in order to run a live-fire range. Instructors/coaches may request other adults, who are registered 4-H volunteers, to assist on the line provided they are familiar with all range safety rules and procedures (these adults **MAY NOT** run or oversee the shooting line).
6. Each shooting range must have available a first-aid kit including a cold pack or ice. In addition, a cell phone or two-way radio must be available to contact emergency services in case of an emergency or to contact range officials regarding safety hazards. If using a cell phone, the Certified 4-H Volunteer must exchange cell numbers with range managers.
7. Shooters participating at a “\_\_\_\_\_ County Sanctioned 4-H approved shooting sports activities” (or training opportunity where “live fire” is conducted) will be listed on a \_\_\_\_\_ County 4-H membership roster and or be able to present documentation (upon the request of shoot officials) of membership in 4-H for sponsored events where participation from outside the County is expected.
8. Any person participating at a Sanctioned 4-H Shooting Sports activity or event, must sign in and out of the range.
9. Shooting facilities used for a Sanctioned 4-H .22 Rifle, Air Rifle, .22 Pistol, Air Pistol, Shotgun, Muzzleloading, Western Heritage, or Archery Shooting Event or Training Opportunity will be used only during daylight hours or for the Event/Training designated shooting hours.
10. The Certified 4-H Volunteer in charge of the firing line is responsible for ensuring that firearms and range equipment is inspected before use. Broken or unsafe equipment shall not be used.
11. The Certified 4-H Volunteer will provide participants with an explanation of safety procedures and appropriate shooting techniques (as it relates to range safety) before shooting begins.
12. The Certified 4-H Volunteer running the line is responsible for supervising and monitoring safety procedures, facilities and equipment used during the 4-H event, activity or training.
13. The \_\_\_\_\_ County Extension Office will ensure that every participant in \_\_\_\_\_ County 4-H Shooting Sports has a current signed copy of the Informed Consent Form on file.

### **Section 3: Safety Considerations**

This section provides general reminders to instructors/coaches running the line during a sanctioned \_\_\_\_\_ County 4-H .22 Rifle, Air Rifle, .22 Pistol, Air Pistol, Shotgun, Muzzleloading, Western Heritage or Archery Event or Training.

1. Be sure that all firearms, archery equipment and related equipment is correct for the event and is safe for shooters to use.
2. Ensure that all shooters have correct eye and ear protection and that it is being used while on the firing line.
3. Check components and equipment for safety, ensuring that: (All firearms/archery equipment and ammunition/arrows are subject to inspection at any time.)
  - a. Proper ammunition/arrow types are being used for the firearm/bow and for the event.
  - b. Appropriate accessories/equipment are being used and that they are safe.
4. Any equipment deemed unsafe or not meeting 4-H safety standards must be removed from the event.
5. Observe to ensure that all projectiles impact within range safety limits.
6. Call “CEASE FIRE” and make safe all firearms when anyone moves forward of the firing line or during any unsafe condition
7. Notify range/shoot officials of any safety infractions.
8. Ensure that all brass, paper and other debris is policed by shooters prior to leaving the line.
9. Ensure that all 4-H Volunteers and members are following all 4-H firearm and archery equipment handling procedures found in Colorado 4-H Youth Development Policies, Colorado 4-H Shooting Sports Leader Training Manual, and Colorado 4-H Shooting Sports State Championships Contest Rule Book.
10. Remind all shooters that SAFETY DEPENDS ON THEM! ALWAYS FOLLOW RANGE SAFETY RULES!

### **Section 4: 4-H Shooting Sports Participant Responsibilities**

1. Follow all Range Rules as posted.
2. Obey all verbal instructions of the line officer and coaches.
3. Ensure range is clear before shooting.
4. Ensure the range is safe before going down range.
5. Cooperate with other shooters.
6. Ensure you wear eye, ear, and foot protection while on the range.
7. Do not handle firearms or archery equipment when people are down range.
8. When not in use, firearms and archery equipment are to be made safe, unloaded, cased with actions open and CBI's in place as appropriate. Firearms and archery equipment that are out of the case and on the firing line are to be made safe and have actions clear and/or open and pointed in a designated safe direction when not being fired.
9. The muzzle of the firearm or archery equipment shall always be pointed in a safe direction.
10. Each shot is to be an aimed, controlled shot.

11. Parents who bring young children are responsible for keeping them under their immediate and direct supervision at all times.
12. All participants must check in with the line officer before going on the line.
13. Participants will conduct themselves according to the Colorado 4-H Code of Conduct at all times and will be responsible for the conduct of any guests they bring.
14. All participants are responsible for their firearms and ammunition or archery equipment while at the range.
15. Only load firearms on the firing line after the line officer has given the command to load.
16. Do not point firearms or archery equipment at anything other than authorized targets.
17. Fire only at your own target.
18. Anyone may give the command “CEASE FIRE” if an unsafe condition exists.
19. Assist in policing the area of brass and any other debris.
20. For the duration of the event or activity, DO NOT CLIMB ON THE BERMS.
21. Horseplay is never allowed on the range.

### **Section 5: Targets**

1. Only approved targets will be used for sanctioned shoots.
2. All targets, backers and target frames for sanctioned 4-H events and training will be arranged, supplied or secured by CSU Extension, \_\_\_\_\_ County. This includes equipment that is rented or utilized from individual range facilities.
  - a. Volunteers and leaders will keep the CSU Extension Office updated on condition of backers and target frames. A physical inspection should occur at a minimum of annually and before any event or practice.
