- ~ In the 4-H classes, Exhibitors enrolled in a 4-H Horse Project show their own project horse(s) & compete at their current 4-H riding level
- ~There will be Boulder County 4-H HLC High Points awarded toward year-end high point awards for classes marked with (**). See County High Point Rules for details.
- ~ Helmets are REQUIRED for all Walk/Trot thru Level I Riders & recommended for all others.
- ~ Management may elect to combine classes with 3 or fewer entries or split classes with a lot of entries.
- ~ Barn C is available to use for riders/horses waiting between classes
- ~ Age as of December 31, 2024 and youth must be 8 years old to participate.
- ~ Open Youth classes are for ages 8-18.
- ~ Open Adult classes are for ages 19+
- ~ Proceeds from this show benefit the Easy Riders 4-H Club Youth
- ~ Riders in walk/trot/jog classes may not enter a class that canters/lopes ~ NO REFUNDS ON SCRATCHES-NO STALLIONS, NO DOGS IN THE INDOOR ARENA, 4-H SAFETY RULES ENFORCED.
