DATE: SATURDAY APRIL 19th, 2025

TIME: 9:00-10:00AM

LOCATION: Barn A, Boulder County Fairgrounds

REQUIRED: ALL market rabbits, Stewers and Roasters, MUST attend to receive their official BCF tattoo, collect DNA, and be nominated for the Boulder County Fair Market Show and Junior Livestock Auction. Only rabbits officially nominated are eligible to participate in the Boulder County Fair Market Show and Junior Livestock Auction. Rabbits must also be entered into the 4HOnline System with their official rabbit tattoo as their animal ID before the last Thursday in April annually.

COST: \$2 per rabbit payable in cash

## **BOULDER COUNTY FAIR RABBIT MEAT PEN ID DAY:**

Because the meat pen of rabbits are smaller and younger animals, there will be a separate Tattoo & Nomination Day and final ID date for the meat pen of rabbits. Note this is only for those animals to be shown in the pen of three meat classes. ALL other rabbits MUST attend the previous rabbit tattoo id day in April.

DATE: Wednesday, July 9th 3:00PM

TIME: 3:00-4:00PM

LOCATION: Extension Office

REQUIRED: ALL market rabbits in the pen of three MUST attend to receive their official BCF tattoo, collect DNA, and nominated for the Boulder County Fair Market Show and Junior Livestock Auction. Only rabbits officially nominated are eligible to participate in the Boulder County Fair Market Show and Junior Livestock Auction. (YOU WILL NOT NEED TO ENTER THESE RABBITS IN 4HONLINE- The 4-H Office will add for you) You will need to do FAIRENTRY. COST: \$2 per rabbit payable in cash

## **BOULDER COUNTY FAIR BREEDING AND COMPANION RABBIT TATTOO REQUIREMENTS:**

All breeding/show rabbits must be legibly tattooed in the left ear. Each rabbit must have a unique tattoo within your family/member owner. For the security and safety, all animals are required to have permanent identification in place to participate in the Boulder County Fair. Permanent Identification may be a tattoo, tag, ear notches, pictures of animals with unique identifiable markings, etc. Tattoos are an ideal permanent Identification for rabbits and can be received on either of the above Rabbit Tattoo Days or you can get tattooed on your own. (Companion Rabbits may have a sharpie marker legible number in ear as a temporary identification at fair)

\*\*\* There are NO make-up dates for Market Animal Nominations for County Fair. Plan to have another family bring your animals if you are not available.
